The initiation fee is waived for the children of members, age 45 and under, who have not previously been regular members, and submit an application on or prior to December 31, 2013

Please consult the by-laws regarding initiation fee payments for members who change from House to Tennis or Regular, Tennis to Regular, or Junior to a Non-Junior Category.

\* Payable in full upon admission.

New members (Excluding Window of Opportunity Members) who pay initiation fees in full at admission will be afforded a 20% discount. Alternatively, initiation fees may be paid in five installments, without interest, with the first installment due at admission and the following four installments due on January 1st of each of the next four years after admission.

The Board voted to extend our "adult children window" to all immediate relatives of existing members, including adult children of all ages, parents, siblings, grandparents and grandchildren. It would not apply to cousins and other "non-immediate" family members. In addition, the family member could apply at a category of membership different from the proposing family member, e.g., a tennis member's brother could join as a regular member, and still benefit from the "window" of no initiation. This family member opportunity was adopted by the Board, for applications prior to November 15, 2013. I encourage all members to consider how they might take advantage of this opportunity with their families.
